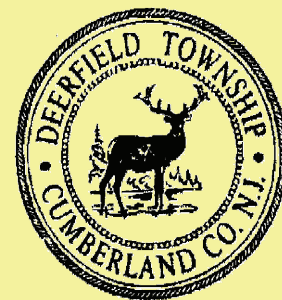
Township, because the landfill, even when it is closed will be in Deerfield Township forever.

- Laurella indicated that the Committee may recommend some street lights be done away with. He stated that each street light costs about \$10 a month, it comes out to \$45,000 a year.
- John Barbagello, Emergency Management Coordinator, stated that everyone in the Township did a fine job with the snow storm and the flooded areas.
- The post office stated that the Census forms had come in to Rosenhayn Post Office but had to be sent back because the forms only had a street address with no name and no post office box. The Clerk indicated that residents who get mail at the post office in Rosenhayn will have to wait for the canvassers to come around and get the census information from them do to this problem.
- The 2010 Municipal Budget of the Township Of Deerfield is \$1,852,698.30. The Local Purpose tax will be 1 Cent Per One Hundred Dollars Of Assessed Valuation.

Deputy Mayor Carol Musso serves as Chairwoman of the Cumberland Development Corp. (CDC), an organization of 8 municipalities in the County, that encourages communication and cooperation among the towns.

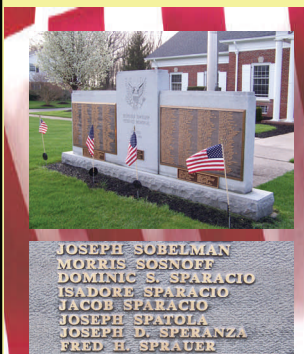

## Frank Spatola Selected as Mayor for 2010

- Committeewoman Carol Musso Serves as Deputy Mayor
- John Stanzione Begins His Fifth Three-Year Term on Township Committee

Frank R. Spatola, Jr. of Vineland Avenue in Deerfield Township was elected by his fellow Township Committee members as Mayor at the Township's annual government reorganization meeting held on Jan. 6.

Spatola, who was born in the township and has lived here most of his life here, was appointed to the Township Committee here in 2008 to fill the unexpired term of the late Charlotte Brago and was elected to a three-year term in 2008.

He served on the Township School Board for six years in the 1980s and two years on the Zoning Board. He is a graduate of Cumberland County College, where he earned an associate's degree in math science.

He and his wife Barbara have two children now in their 20s. He owns Spatola Builders, a local construction company.

John Stanzione of Morton Avenue in Rosenhayn began his 13th year on the Township Committee as he was sworn in to a new three-year term after winning re-election in November. Stanzione has served as Deputy Mayor and Mayor during his years of service on the Township Committee.

Carol Musso of Rosenhayn, who served as Mayor in 2009 and who has served many years on the Committee, was selected as Deputy Mayor.

She received a plaque from new Mayor Spatola in thanks for her service as Mayor. The other two members of the Township Committee are Keith Lauermann and Cosmo Laurella.

Spatola thanked the people of the Township for giving him the opportunity to serve on the Township Committee saying, "I sincerely appreciate all the residents, family members and friends who are attending tonight and as I have always said, the ideas, comments and participation of the public are important at all of our meetings."



## DEERFIELD TOWNSHIP VETERANS MONUMENT TO BE UPDATED

The Township's committee will have a new sidewalk built around the Township's Veterans Monument and add new names to it by this fall.

A re-dedication ceremony is being planned for Veteran's Day, Nov. 11.

The new sidewalk will make access to the front of the monument easier for everyone including those with wheel chairs and walkers.

## BUDGET KEEPS LOCAL TAX LOW DESPITE REDUCTIONS IN STATE AID TO TOWNSHIPS

The Township Committee approved the 2010 budget which is lower than 2009 and sets maintains the township's local purpose tax rate at 1 cent per \$100 of assessed value.

With cuts in State aid to municipalities due to the State deficit, the Mayor, entire Township Committee and staff worked hard to maintain the local purpose tax at 1 cent, the same rate since 2005. The budget includes no increase in salary for Township Committee members as it did in 2009.

Deerfield is also working with Upper Deerfield and other municipalities through Cumberland Development Corp. to come up with more savings using sharing services.

"We were able to offset cuts in State

funds with increases in host community payments from Cumberland County Improvement Authority and by increasing our use of township surplus funds to keep our local tax very low and still be able to provide the best services possible for all of our residents in all areas of Deerfield Township," said Mayor Frank Spatola.

## Harvest Festival Adds \$1 Admission Fee for First Time

The 32nd Deerfield Township Harvest Festival will feature concerts by Country music stars Darryl Worley, Sarah Buxton and Jason Michael Carroll, with more nationally-known and other entertainers to be announced in the coming weeks. See [www.dthf.org](http://www.dthf.org).

In order to continue a tradition of providing this type of stellar national, regional and local musical entertainment to the thousands of visitors each year, a very modest \$1 admission fee for anyone over 12 years old has been approved.

Children 12 and under will be admitted without charge. The \$1 fee

allows people to enter and exit unlimited times on the day they pay for admission and to enjoy the musical entertainment and many other parts of the festival.

There will be no admission charge for Friday evening, family night at the festival.

For those who park vehicles in the festival's official parking lot, the \$5 parking fee will also include free admission into the festival for up to 6 people in the vehicle.

For 31 years, the financial support of sponsors and advertisers has made it possible to keep the Festival a free, family-oriented event

with no general admission fee.

Unfortunately, the effects of the times have caught up with us -- the economy, budget cuts, less sponsorships and grant cuts.

The festival will "Celebrate Heroes" featuring a salute to true heroes, our United States Armed Forces. It will include the traditional recognition of farmers and their importance to the township's history and its rural way of life.
